**WHEREAS**, Resolution 17-002 created the Chehalis River Basin Flood Control Zone District Advisory Committee per RCW 86.15.070; and

**WHEREAS**, Resolution 17-003 appointed eleven (11) members to the advisory committee with the following terms:

1. Daniel T. Maughan, David Mueller, Jason Humphrey, and Steve Koreis to three (3) year terms expiring September 13, 2020.
2. Bill Brumsickle, Charles Coddington, John Henricksen, and Lonnie Willey to two (2) year terms expiring September 13, 2019.
3. Matthew Dillin, David Fenn, and Steven Grega to one (1) year terms expiring September 13, 2018; and

**WHEREAS**, Resolution 18-002 appointed Bonnie Coumbs to the advisory committee for a three (3) year term expiring August 13, 2021. The resolution also renewed the appointments of David Fenn and Steven Grega for three (3) year terms expiring August 13, 2021 and removed Steve Koreis and Matthew Dillin from the committee.

**WHEREAS**, Resolution 19-005 renewed the appointments of Bill Brumsickle, Charles Coddington and John Henricksen to two (2) year terms expiring August 28, 2021 and also removed Lonnie Willey from the committee; and

**WHEREAS**, Resolution 20-005 appointed Frank Corbin to the District Advisory Committee for a two (2) year term expiring September 13, 2022. The advisory committee is now at (10) appointed members; and

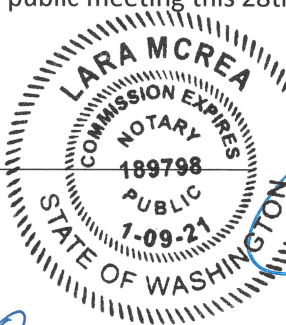
**WHEREAS**, Daniel T. Maughan, David Mueller and Jason Humphrey have three (3) year terms that expired on September 13, 2020; and
